Dear Senator,

I decided to forward this letter in the interests of justice, and of having a (Criminal inquest) started into how-and-why I was charged with murder, convicted and sent to [Death Row]. All MY charges are - against the false charges that they used against me to send me to [Death Row], is "old. CONSTITUTIONAL and CIVIL RIGHTS violations. knowingly and intentionally using all false evidence. "I" absolutely maintain my innocent understanding in the same breath it those who will say innocent is a matter of law! That only make it worst.

It should be noted, I addressed and sent documents to the U.S. Atty. Gen. John Ashcroft also seeking a criminal investigation into this Case (Nov. 18, 2003) for CIVIL RIGHTS violations under the color of authority. (OVER)

I did receive a response (Dec. 13, 2005) from Abbott N. Moskowitz (Asst. Chief Criminal Sec. [Civil Rights division]) in part stating,

"their enforcement activity, primarily involves deprivation of CIVIL RIGHTS under the color of authority / law, which generally involves the use of excessive physical force by law enforcement officials. . . However they had determined that my Complaint does not involve a prosecutable violation of federal Criminal Civil Rights statutes."

I am in total disagreement with their declaration. I take the word generally to mean there is exception to that rule. My charges would be that exception to that rule. I pointed out why by the use of law.

Again, as I start to close, I maintain my position, and humbly request a inquiry and inquest is started in MY charges.
